3 (a) The objects to be pursued by the company on its incorporation are:

To undertake, promote, establish, support, carry out, and facilitate charitable activities for the advancement of social welfare, education, healthcare, environmental protection, cultural development, community welfare, and other activities of general public utility on a not for-profit basis for the benefit of society, particularly for the underprivileged, economically weaker, marginalized, vulnerable, and disadvantaged sections of the community.

To promote and provide education, literacy, digital literacy, constitutional awareness, vocational education, skill development, professional training, entrepreneurship development, career guidance, and self employment opportunities; to establish, run, support, manage, and maintain schools, tuition centers, learning centers, libraries, reading rooms, training institutes, hostels, and other educational facilities for children, youth, women, and adults.

To undertake programs for women empowerment, youth development, rural

development, social inclusion, livelihood generation, capacity building, leadership development, financial literacy, and community participation through workshops, seminars, awareness campaigns, training programs, counseling services, and other developmental initiatives.

To promote healthcare and public health by organizing medical camps, health awareness programs, mental health counseling, preventive healthcare initiatives, maternal and child healthcare programs, nutrition awareness campaigns, de-addiction and rehabilitation awareness programs, sanitation drives, and by supporting access to healthcare services for the needy and underserved sections of society.

To undertake activities for environmental protection and sustainable development including tree plantation drives, biodiversity conservation, pollution control awareness, waste management initiatives, renewable energy awareness, water conservation programs, climate change mitigation and adaptation measures, and promotion of environmentally responsible practices.

To promote animal welfare and protection by undertaking activities for the care, rescue, treatment, rehabilitation, feeding, shelter, and welfare of animals and birds and by creating awareness regarding animal rights and compassionate treatment of animals.

To support and assist senior citizens, orphaned children, destitute persons, persons with disabilities, widows, and other vulnerable groups through welfare programs, relief measures, counseling, rehabilitation, education,

healthcare, livelihood support, and community-based assistance.

To preserve, promote, and disseminate Indian art, culture, literature, heritage, traditions, values, patriotism, and national integration; to organize cultural, educational, and awareness programs, exhibitions, festivals, competitions, and events for public benefit and cultural enrichment.

To undertake activities for the welfare and support of families of martyrs, ex-servicemen, and other persons who have rendered distinguished service to the nation and to promote national unity, civic responsibility, and constitutional values among citizens.

To promote Swadeshi initiatives, self-help groups, cottage industries, micro-enterprises, traditional crafts, rural industries, and sustainable livelihood projects aimed at economic empowerment and community development.

To collaborate with Central Government, State Governments, local authorities, educational institutions, hospitals, charitable organizations, trusts, societies, corporate entities, international organizations, and other stakeholders for carrying out and achieving the charitable objects of the Company.

To undertake relief activities during natural or man-made disasters, emergencies, epidemics, pandemics, and other calamities by providing food, clothing, shelter, medical assistance, rehabilitation support, and other humanitarian aid.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

To do all such lawful acts, deeds, matters, and things as are

incidental or conducive to the attainment of the above objects, provided that the Company shall apply its profits, income, and other earnings solely for the promotion of its objects and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus, or otherwise to its members, except as permitted under the provisions of Section 8 of the Companies Act, 2013 and applicable laws.

the doing of all such other lawful things as considered necessary for the furtherance of the above objects:

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

9 True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of which such receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the regulations of the company for the time being in force, the accounts shall be open to the inspection of the members. Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.

11 The Company can be amalgamated only with another company registered under section 8 of the Act and having similar objects.
